The grain fundamentals remain with tight supplies, record demand and trouble getting crops in the ground in many areas. Corn planting progress came in at 86% complete, up 7% from last week but still below trade estimates of 88-90% and well below the 95% average for this time of year. Soybeans are currently 8% below the trade estimate at 51% complete. When looking at Nebraska even with the rainfall we have received corn is currently only 1% below the average planting progress for this time of year at 97% and 6% below the soybean average at 78%. While Nebraska isn't lagging far behind looking at the northern portion of the grain belt is significantly behind and many acres that were planned for corn will have to be switched over to soybeans. This will put a lot of attention to the acreage report at the end of June which should bring some very important fundamental knowledge for both crops.

Important Dates to remember:

June 1, 2011 – Deadline to sign up for the 2011 Direct and Counter-Cyclical Program (DCP) and Average Crop Revenue Election Program (ACRE). So far in most counties there are only two crops, wheat and oats, that have met the state trigger for ACRE payments. If a producer misses the June 1, 2011 deadline there is a late-filing time period from June 2, 2011 thru August 1, 2011. Producers may still enroll in DCP or ACRE during the late-filing time period. All owners and operators who will share in the DCP or ACRE payments on the farm must sign the CCC-509 by August 1st to remain eligible for 2011 program benefits. Faxed signatures are also acceptable on a DCP or ACRE contract. Changes that affect DCP or ACRE program need to be reported to your local office by September 30, 2011 because changes may cause a refund of all 2011 program benefits.

June 30, 2011- Deadline for small grain acre reporting for producers to qualify for 2010 NAP benefits, producers are required to certify or provide crop production history and report current crop year production on or before the immediately subsequent crop acreage is reported. Producers should bring in prior year production history when certifying 2011 acres.

July 15, 2011- Deadline for large grain acre reporting for producers to qualify for 2010 NAP benefits, producers are required to certify or provide crop production history and report current crop year production on or before the immediately subsequent crop acreage is reported. Producers should bring in prior year production history when certifying 2011 acres.

July 15, 2011 – Deadline to file the 2010 FSA-658 production report for each farm enrolled in the ACRE program. Failure to file an FSA-658 report for each ACRE farm will result in the farm's ineligibility for all ACRE benefits, including DIRECT payments.

January 10, 2011 – 2009 SURE (Supplemental Revenue Assistance Program) sign-up began and runs through July 29, 2011. SURE is a revenue assistance program so once you have had a 10% qualifying production loss the revenue portion of the SURE equation kicks in resulting in some sizable payments, especially for those farmers who had higher levels of crop insurance on crops. There are no stimulus SURE payments for the 2009 crop year as there were for 2008. Only the 2009 basic SURE payment will be issued. If you feel that you may have had a qualifying loss, contact an office right away for an appointment.

August 1, 2011 – Nomination forms for the 2011 election for County Committee must be postmarked or received in the local Service Center by close of business.

It is always a good idea to do a yearly farm review to ensure all your equipment is added correctly to your farm policy.
